On Careful consideration of the proposal, the Government of Karnataka has decided to issue an Essentiality certificate and Feasibility Certificate to the applicant for commencing 150 seats of MBBS Course from the academic year 2024-25.

It is certified that:-

- a) The applicant owns and manages a 605 bedded hospital for functioning with 150 MBBS seats.
- b) It is desirable to commencing 150 seats of MBBS Course in the public interest.
- c) Commencing 150 seats of MBBS Course at BGS Medical College and Hospital (BGS MCH), Nagarur, Dasanapura, Bangalore North taluk by Adichunchanagiri University is feasible.
- d) Adequate clinical material as per the Medical Council of India norms is available.
 - It is further certified that in case the applicant fails to create infrastructure for the medical college as per NMC norms and fresh admissions are stopped by the Central Government /NMC, The State government shall take over the responsibility of the students already admitted in the College with the permission of the Central Government /NMC.
- e) BGS Medical college and Hopsital, (BGS MCH) at Nagaruru, Dasanapura, Bangalore North Taluk, Bangalore owns and possesses 16 Acres/Guntas of land In Nagaruru Village, Bangalore on which non-agricultural use of land is permitted and a Medical College/Hospital already existing.
- f) The building plan of the Hospital and Medical College has been approved by the competent Authority, namely, Panchayat Development Officer, Dasanapura Gram Panchayat, Bangalore North taluk designated by the State Government for such purposes on 30.06.2023/(copy of the approval is enclosed)
